### I. Description of Proposed Improvement

Project Limits: I-275 from Howard Franklin Bridge eastward to the Dale Mabry Highway interchange and shall be documented as an Environmental Assessment; the Himes Avenue interchange eastward to 50th Street interchange on I-4 and north to the Buffalo Avenue interchange on I-275 and the Crosstown Connector in the vicinity of 30th Street on I-4 southward to the Crosstown Expressway and shall be documented as an Environmental Impact Statement.

Level of Significance: Environmental Assessment and Environmental Import Statement (EA & EIS).

### IV. Public Meetings

The following information meetings will be held to involve the public and interested agencies in the project development process and to inform interested parties of the project's current status:

- A second notification in the form of an Introductory or Kickoff/Coordination meeting announcing Phase II shall be held with elected/appointed officials.
- One (1) Public Workshop Meeting is anticipated to publicly present the viable design alternatives for this project.
- Two (2) formal hearings will be held in accordance with state and federal law to present the proposed alternatives one (1) hearing for the Environmental Assessment and one (1) for the Environmental Impact Statement.
- v. Coordination with the Metropolitan Planning Organization
  To assure project coordination with the Hillsborough County MPO, an
  MPO staff member has been included as a member of the Agency Task
  Force. In addition, the Department or its representative will

attend any Hillsborough or Pasco County MPO meetings where the project study is addressed on the Agenda.

### VI. Analysis and Evaluation of Public Input

A transcript of the Public Workshop and each hearing (EA and EIS) will be developed, to include written comments received at the workshop and those received ten (10) days after the workshop and hearings.

A staff de-briefing will be held subsequent to each public information workshop and hearing to assess all issues identified and comments received. A report will be prepared summarizing the discussion of issues and comments. Issues identified in the workshops will be addressed through the preparation of follow-up newsletter, distribution of news releases or other appropriate techniques. Responses to all questions and comments not answered at the workshops will be made in writing.

### VII. Public Hearing

In compliance with the Federal Law, Florida Action Plan and Florida Statute 334.211, a public hearing will be held for the Environmental Assessment and the Environmental Impact Statement once the concept design alternatives have been presented. At this public hearing the public can formally offer data concerning the project. The hearing is usually held with an informal format (PD&E Guidelines Manual, Part 1, Chapter 8-2.8.2).

PUBLIC ADVERTISEMENT: Legal Advertisement will be noticed in the <u>Tampa Tribune</u>.

LETTERS OF INVITATIONS: Letters will be written to all property owners as required by Florida Statute 334.211 and to local government officials to notify them of the upcoming public hearing.

HEARING PREPARATION:

Tape recording, slide presentations, graphics and handouts will be prepared to supplement the oral public hearing presentation.

TRANSCRIPT:

A transcript of the public hearing will be developed, to include written comments received at the hearing and written comments received ten (10) days after the hearing. The transcript will then be forwarded to the FHWA Division Office.

## VIII. Public Hearing Follow-Up

The following procedures will be undertaken after the public hearing.

RESPONSES: Responses to all questions and comments not answered at the public meeting will be made in writing.

DOCUMENT AVAILABILITY: Public notice will be provided by mail and/or by newspaper advertisement as to where the study document is located for public review.

RECOMMENDATION NOTICE: A legal notice announcing the Federal Highway Administration's approval of the final document and recommendations will be published in the <a href="Tampa Tribune">Tampa Tribune</a>. In addition, news items detailing the Department's recommendations to FHWA will be provided to the local media.
